There were questions and answers about the information in the Board packets.

Ms. Shay arrived at 6:07 PM. She gave a brief overview of the information from the last meeting and explained more in detail about the key information to help the Board. A PowerPoint was shown. She Option 1: 18.5844 mills; Option 2: 18.5844 mills plus .5 mill increase for a total of 19.0844.

The Board would have to determine if they wanted a May or August election date, the number of years, and the amount of the millage. Once those are determined and the information is sent to Ms. Shay, she would provide the District with a Resolution, and a draft ballot.

Ms. Shay said if the Board decided to have a May election that she had the following two recommendations for them to pick from:

- 1) The Board could decide on the Ballot language tonight, pass the Resolution and file it by the deadline on February 11, 2020.
- 2) The Board could think about it, weigh the options, and decide at the Regular Board meeting on February 10, 2020. The Resolution would have to be filed with Wayne County Clerk before 4:00 PM on Tuesday, February 11, 2020.

Assistant Superintendent McIntyre preferred 10 years at 18.5844 due to other things that they would like to do in the District, such as a Bond or Sinking Fund.

President Gubachy gave her support for Option 2 - 10 years at 18.5844, and she asked that the word "Renewal" be added to the header.

There were questions and answers.

Board of Education Communication/ Discussion Member Gray preferred an August Election for 10 years at 19.0844 mills.

Member Kick preferred an August Election.

Per President Gubachy, she spoke with Treasurer Osowski, and although he could not vote due to his absence, he preferred a May election for 19.0844 mills.

Member Robinson preferred an August Election.

There was no motion to have a May Election.

The Board will file for an August Election.

Terry Arriola, Business Office Staff Assistant, would email the Board a reviewed copy of the PowerPoint.
