First Reading of the Complete Revised Policy Manual

First Reading of the Complete Revised Policy Manual

It was moved by Member Caloia, seconded by Member Doby.

Kevin Sutton, of Lusk-Albertson, gave a brief overview of the draft of the proposed Board Policy Manual. Board members pointed out changes from current policy, procedure, and practices. Based on these communications, the following amendments were made to the proposed policy manual and will be included in the document that will be presented to the Board at its regular meeting on November 13, 2017:

1. Section 1001 – Term of Office changed from four years to six years
2. Section 1002 – Annual Organizational Meeting change “January” to “July.”
3. Section 2006 at page 11 – Long-Term Suspensions and Expulsions – add “ may be appealed to the Board of Education” at the end of the last sentence
4. Section 2006 at page 14 – Personal Electronic Devices – add “(high school students only)” at the end of second bullet point
5. Section 8002 – Designate Ronald Ward, Assistant Superintendent of Human Resources, as Section 504/ADA Compliance Officer and Kimberly Crenshaw, Interim Director of Education Technology as the Web Accessibility Coordinator
6. Section 8003 – Insert link n District website for access to FAPE guidelines and designate Ronald Ward, Assistant Superintendent of Human Resources as the Compliance Officer for employment issues arising under Section 504 and the ADA and for FAPE and other accessibility issues arising under Section 504 and the ADA
