Bid Overview #7 – Plant Moran Cresa, The Christman Company, French Associates

The team reported that the only presentation they would have tonight was the letter the Board received which was the award recommendation letter on Bid Package #7. The big quotes actually came in significantly under budget. He credited the architectural team for designing a project that was tight to budget. The Christmas team for really covering all bids as well as the timing. Then the overall scope is to have all this work completed or substantially completed by the start of the school year for next year. The recommendation from the construction team was to not go with the lowest price bidder, but to go with the second lowest price bidder. The Christmas team had outlined why that contract was selected; the difference was a very small dollar amount.

The bond Council was asked to weigh in to give their official opinion about how legally they could proceed and the Bond counsel Rob Gavin with Collins and Blaha pointed out, it is really at the discretion of the Board to make those definite decisions about the lowest qualified bidder. The Christmas team spoke about their process and explained why the lowest bidder was their selection. Ecker Mechanical bid was \$1,531,900 and Quality Aire bid was \$1,543,000.

President Pridemore had question that was not in regard to Bid Package 7, and she would send them to Mr. Lamberto.

Student Services (Parent's Resources Guide) – *Tamaran Dillard, Executive Director of Student Services* 

Ms. Dillard reported on the Redford Union's Parent Resource Handbook, a reference guide to understanding special education. A PowerPoint presentation was shown. The handbook was designed for our parents, staff, our community members, service providers, whoever needs some understanding Information on our student services department.

The Parent Resource Guide would be provided to the building administration to be sent to parents and posted online. She said that they are working on down the road to have a Parent University, and they hope to have parents come in once a month and there might be a theme once a month on special Ed.

Treasurer Moores asked if there would be a key contact section in the handbook.

Ms. Dillard said she would add it.

Treasurer Moores also asked if it could be communicated that it is not just for learning disabilities, but also for like emotional impairment as well.

Ms. Dillard responded, yes.

Preliminary Enrollment & School of Choice

Mr. Beltinck said as a rough count the numbers they received in excess of about 250 applications this year, it was down for the previous years. A lot of that is we are now in our third school year after the COVID shutdown. He will report on the numbers once the count comes in, in early October, and he will get the Board some preliminary numbers once the audited numbers come back. They are hoping to hold at the current high of 2,900 students.

Food Service Hourly Wage Rate(s)

Mr. Beltinck reported that back at the end of last school year he worked with Angie Davis, the District's Food Service Director, who is shared with Farmington schools. They pulled together a little matrix that he shared with the Board. They made a comparison with the Farmington schools.

After the Bond, the District will look at making long-term EduStaff to RU staff. Rewarding staff but staying within the market price. Superintendent Witt authorized a \$1 increase across the Board.

There were questions and answers.

The Board expressed their concerns with the current hourly wage of the Food Service workers.

Trustee Bailey will contact Farmington Schools for his own research.

Treasurer Moores shared that she had reached out to some other school districts, reviewed job postings and district websites. She would still like to research more. The Board expressed that they still wanted the workers to receive the \$1 increase October 1, 2023, and it was asked if \$0.50 could be added, while more research is done.

Mr. Beltinck shared that the auditors would be on site this week, Tuesday, Wednesday, Thursday at Keeler. They had been working with them for the last four to five days directly.

All of our new staff, whether they are new to teaching or just new to the district will receive a mentor for a year and there is a provision in the teachers' contract that we do pay mentors to provide that help for these new teachers. Every new teacher to the field will have a mentor for three years. Ms. Nachman, Kim Crenshaw, Executive Director of Curriculum/Technology and Chris Norton, Coordinator of Teaching and Learning will be getting together our new Teacher Academy. The new staff will go through additional training and professional development after school, and it will be a requirement that their mentor teacher attends with them. Both will be paid. New teachers, brand new teachers to the field are required to do an additional 15 days of professional development in their first three years and the district is responsible for providing it. If a teacher chooses not to participate, they will have to access it on their own. But we are required to provide It.
