Wayne RESA would post the vacancy and go through their process which is similar to what the Board had done. Wayne RESA would do interviews of anyone who applies, and it would not be limited to the 2 candidates. The candidates would apply to Wayne RESA then the Wayne RESA board would conduct the interviews, make a selection, and appoint a member to the Board.

It was also recommended that the Board members could state their own ranking of where they are based on what they have heard at this point in time between the two applicants. And then that might. Lead them to a spot.
