Member Caloia asked that Mike Humitz, Assistant Principal of RUHS word his letter better regarding Restorative Practices going forward.

Supt Shivers said that there are different ways to do Restorative Practices: 1) Restorative Practices can be done as a way to heal afterward, and that is the way the letter was worded. She is advocating for a re-entry circle way before the student returns with possibly some restitution that will put the student on a timeline of reaching certain goals.
